

2025 Vendor Application

Market Location

• Market will operate from 3pm to 7pm in the 9th Ave parking lot next to the Homestead United Presbyterian Church, 9th Avenue and Ann Street, Homestead, PA.

Application Process

- All applicants must complete a vendor application and return it with full payment and all required forms and licenses before consideration for participation at Steel Valley Farmers Market.
- Vendors will be notified of acceptance by e-mail.
- Submitting an application does not guarantee acceptance into the market.
- Applications will be accepted throughout the season; however, space is limited so you are encouraged to submit your application early.

Vendor Criteria

- Items must be home grown, locally produced or made by the vendor.
- All prepackaged products must be prepared in accordance with the rules established by the Allegheny County Health Department.
- The number of vendors in each category is limited in order to prevent saturation in one category.

Products NOT Appropriate for Market

• Non-profits, those running for elected office, fundraising groups and/or organizations wanting to promote their company. Materials may be dropped at the Community Booth.

Space Assignment

- Transfer of market space assignments is prohibited.
- Vendors are responsible for the clean-up of their individual space.
- Vendors will provide their own tables, table covering, tents, garbage bags, and signage.
- All vendors are required to provide sales to all market customers, regardless of race, color, national origin, religion, gender, age or disability.
- Participants must arrive at least 30 minutes prior to the stated market opening time.
- For safety reasons, all vendors are required to remain open until the market closes.

Permits, Licenses, and Insurance:

It is the vendor's responsibility to have all the correct licensing, permits and insurance. Additional licensing from Allegheny County Department of Health may be required to participate in the market. Please contact them to ensure that you are fully licensed. **INCLUDE WITH APPLICATION**.

Participants must comply with all applicable local, state, and federal regulations as applicable. These include but are not limited to the following:

- a. Pesticide licensing and safe use.
- b. Certification of scales by the department of weights and measures.
- c. Organic certification for products claimed to be organically grown.
- d. State sales tax where applicable.
- e. Health and labeling regulations that apply to preserves, honey, cider, baked goods, canned goods, eggs, dairy products, meats, etc.
- f. Health code provisions and licensing.
- g. Compliance certification documentation may be requested by the Manager at any time during a Market.

Prepared Food Vendors:

Prepared food for onsite consumption must comply with all applicable Allegheny County Health Department rules and regulations concerning the licensing and operation of temporary food establishments. Cooking food items on Market premises without prior permission of the Manager is prohibited. Participants must comply with Pennsylvania and Allegheny County regulations regarding the handling and storage of food. Pre-packaged and prepared items must comply with applicable labeling laws. All Participants offering food samples are responsible for the safety of the samples being offered.

Vendors preparing food onsite must have their own fire extinguisher readily available for the duration of each market.

Substance Use:

No smoking or tobacco use of any kind is permitted. Consumption of alcoholic beverages or controlled substances is strictly prohibited.

Pets:

Due to crowds and safety issues, we are requesting that you leave your 4-legged friends at home.

No Show Policy:

All vendors must give notice to the market manager by Friday of the week prior to Market date if unable to attend.
